

**CBHS Corporate Health Pty Ltd**  
**Four Weeks Free and 2 & 6 Month Waiting Periods**  
**TERMS AND CONDITIONS**

1. Information on how to enter and register for the Four Weeks Free and 2 & 6 Month Waiting Periods (**Promotion**) form part of these Terms and Conditions. Participation in this Promotion is deemed acceptance of these Terms and Conditions. This Promotion is not valid in conjunction with any other offer.
2. The promoter is CBHS Corporate Health Pty Ltd ABN 85 609 980 896 of Level 5, 79 George Street, Parramatta, NSW, 2150 (**Promoter** or **CBHS Corporate**).
3. This Promotion commences at 12:00am (AEDT) on 5 April 2019 and closes at 11:59pm (AEST) on 30 June 2019 (**Promotion Period**).

**Definitions**

4. For the purposes of these Terms and Conditions:
  - a. **CBHS Corporate Extras Cover** means [Premier Extras](#), [Value Extras](#) or [Starter Extras](#) as defined in the Health Benefit Fund Rules of CBHS Corporate;
  - b. **CBHS Corporate Hospital Cover** means [Gold Hospital](#), [Silver Plus Hospital](#), [Bronze Plus Hospital](#) or [Entry Hospital \(Basic Plus\)](#) as defined in the Health Benefit Fund Rules of CBHS Corporate;
  - c. **Eligible Policy** means a current and financially active policy with CBHS Corporate that includes both CBHS Corporate Hospital Cover and CBHS Corporate Extras Cover commencing during the Promotion Period;
  - d. **Gift** means:
    - i) Four weeks free cover is applied at the end of the third month of cover held on an Eligible Policy; and
    - ii) the waiver of the two and six month waiting periods which usually apply to CBHS Corporate Extras Cover.

**Eligibility**

#### **Waived Waiting Periods**

14. To be able to claim the waiver of 2 & 6 month waiting periods on Extras Cover, Eligible Applicants must join CBHS Corporate and hold CBHS Corporate Hospital Cover and CBHS Corporate Extras Cover for 90 days from the time they join CBHS Corporate.
15. Any applicable waiting periods which are more than six months, including waiting periods for CBHS Corporate Hospital Cover or pre-existing conditions will continue to apply.
16. This waiver is not transferable or exchangeable and cannot be taken as cash.

#### **General**

17. The Promoter reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the process or the operation of the Promotion.
18. If this Promotion is interfered with in any way or is unable to be conducted as anticipated as realistically expected due to any factor beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to modify, suspend, terminate or cancel the Promotion, as appropriate.
