

# CBHS Corporate Health Pty Ltd Choose Your Own Gift Promotion TERMS AND CONDITIONS

1. Information on how to enter and register for the Choose Your Own Gift Promotion (**Promotion**) form part of these Terms and Conditions. Participation in this Promotion is deemed acceptance of these Terms and Conditions. This Promotion is not valid in conjunction with any other offer.
2. The promoter is CBHS Corporate Health Pty Ltd ABN 85 609 980 896 of Level 5, 79 George Street, Parramatta, NSW, 2150 (**Promoter** or **CBHS Corporate**).
3. This Promotion commences at 12:00am (AEST) on 1 October 2018 and closes at 11:59pm on 31 December 2018 (**Promotion Period**).

## Definitions

4. For the purposes of these Terms and Conditions:
  - a. **CBHS Corporate Extras Cover** means [Gold Extras](#), [Silver Extras](#) or [Bronze Extras](#) as defined in the Health Benefit Fund Rules of CBHS Corporate;
  - b. **CBHS Corporate Hospital Cover** means [Gold Hospital](#), [Silver Hospital](#), [Bronze Hospital](#) or [Base Hospital](#) as defined in the Health Benefit Fund Rules of CBHS Corporate;
  - c. **Eligible Policy** means a current and financially active policy with CBHS Corporate that includes both CBHS Corporate Hospital Cover and CBHS Corporate Extras Cover commencing during the Promotion Period;
  - d. **Membership** means a single, couple, family or sole parent membership.
  - e. **Eligible Applicant Gift or Gift means**
